In 2021, the combined value of poultry production exceeded €3.6 billion, accounting for 17.15% of the country's final livestock production (12.2% corresponds to the poultry meat sector and 4.95% to the eqg production sector).

Poultry production is characterized by a high degree of supply chain integration. Year after year there is a greater concentration of operators, generating benefits for the entire national poultry sector. There are also small farms supplying a local and proximity market, which allows for a very varied offer for consumers. The majority of the poultry sector is self-sufficient and there is a growing export vocation.

We look forward to welcoming you in Valencia the 22nd September 2023 to present all the opportunities and benefits that our Conference offers to your company and to discover the Valencia Conference Center and our city.

Terms & Conditions:

This application, properly executed by Applicant (Exhibitor) shall, upon written acceptance and notification of booths assigned by EPC 2024 Organizing Committee, constitute a valid and binding contract.

1. Assignment of Space

Assignment of space to exhibitors and those making application will be made in the order of email date.

EPC 2024 will continue to receive applications and assign exhibit space, as it remains available, until shortly before the exhibition opening date.

In all cases, total booth payment must be received prior to exhibition opening. EPC 2024 assignment of booths is final and shall constitute an acceptance of the Exhibitor's offer to occupy space.

After assignment, space location may not be changed, transferred or cancelled by the Exhibitor except upon written request and with the subsequent written approval by EPC 2024.

EPC 2024 Organizing Committee reserves the right to reassign Exhibitor space or to modify floor plan for overall benefit of the exhibition.

2. Subletting Space

No exhibitor will assign, sublet, or apportion the whole or any part of the space allotted to him, nor exhibit therein, nor permit any other person or party to exhibit therein, any other goods, apparatus, etc. not manufactured or distributed by the Exhibitor in the regular course of his business except upon prior written consent of the EPC 2024 Organizing Committee

3. Payment Requirements and Cancellation Charges

Applications require a 50% deposit before final booth assignment is confirmed in writing. All applicants who contract after 1 October 2023 must be paid in full by 1 March 2024. All applications received after 1 March 2024 must be accompanied by full payment. All cancellations must be made in writing and will be based on the following schedule of refunds: Space reductions are considered cancellations and may be subject to cancellation fees.

On or before 1 March 2024, 50% of total booth cost, less a €100 service fee, will be refunded. After 1 June 2024, no refund will be permitted. Noshow exhibitors will receive no refund. It is understood that EPC 2024 reserves the right, at its option, to reassign a cancelled booth regardless of the cancellation rate assessed. In the event that the premise in which the EPC 2024 Organizing Committee Exhibition is conducted shall become, in the sole discretion of EPC 2024 Organizing Committee, unfit for occupancy, or substantially interfered with by reason of any cause or causes not reasonably within the control EPC 2024 Organizing Committee, this agreement may be terminated by EPC 2024 Organizing Committee. For this purpose, the term "cause or causes" shall include, but not by way of limitation, fire, flood, epidemic, earthquake, explosion or accident, blockage, embargo, inclement weather, governmental restraints, restraints or orders of civil defense, or military authorities, act of public enemy, riot or civil disturbance, strike, lockout, boycott or other labor disturbance, inability to secure sufficient labor, technical, or other inability to obtain, or condemnation, requisition or commandeering of necessary supplies or equipment, local, state or federal law, ordinance, rule, order, decree or regulation, whether legislative, executive, or judicial, and whether constitutional, or act of God.

Should EPC 2024 Organizing Committee terminate this agreement pursuant to the provision of this paragraph the Exhibitor waives any and all claims for damages and agrees that EPC 2024 Organizing Committee may, after computing the total amount of EPC 2024 Organizing Committee cost and expenses in connection with its preparation for and conducting of the EPC 2024 Organizing Committee Exhibition, (including a reasonable reserve for claims and other contingencies) refund to each exhibitor the amount paid for the space, less a proportionate share of all the expenses incurred by EPC 2024 Organizing Committee.

4. Set-up and dismantling of the exhibition stand:

A representative shall man the exhibit space during the entire time the Exposition is officially open. The exhibition space must be kept clean and tidy throughout the duration of the Exhibition. Once your reservation is confirmed, you will be given a schedule for the set-up and dismantling of your booth and materials to be exhibited. Failure to comply with this rule, including early dismantling, will result in a fine of 500 (Euro) and may jeopardize the exhibitor's space allocation or his right to exhibit at future conferences sponsored by the EPC 2024 Organizing Committee.

5. Loss or Damage

Exhibitor agrees that EPC 2024 Organizing Committee shall not be liable for any damage or liability of any kind or for any loss, damage or injury to persons or property during the term of this agreement, from any cause whatsoever by reason of use, occupation and enjoyment of exhibit space by Exhibitor or any person thereon with the consent of Exhibitor, and that Exhibitor will defend, indemnify and save harmless, EPC 2024 Organizing Committee from all liability whatsoever, on account of any such damage, or injury, whether or not caused by negligence or breach of an obligation by Exhibitor or its employees or representatives. Exhibitor will be liable for all damages or liability of any kind or for any loss, damage or injury to persons or any property during the exhibition from any cause whatsoever by reason of use, occupation and enjoyment of exhibit space.

6. Demonstrations

No demonstrations or solicitations shall be permitted outside of the Exhibitor's assigned space, and no signs or placards may be displayed on persons or otherwise outside exhibit spaces.
